She has also previously served as a long-time board member for The Gathering Place, Denver's only daytime shelter for women, children, and transgender individuals experiencing poverty. In addition, she is a mentor for Law School . . . Yes We Can, which is the first law school pipeline program in Colorado to target high-achieving first-year college students from diverse backgrounds and provide them access to the legal profession. Theresa was also a fellow for the Leadership Council for Legal Diversity (LCLD) and serves as the co-chair of the Davis Graham Women in Leadership Lecture Series (WILLS).
